In recognition of International Overdose Awareness Day

IDHDP supports the efforts in communities around the globe to prevent drug overdose fatalities and calls for greater governmental and international policymaker leadership.

IDHDP statement of support: "The War on Drugs and HIV/AIDS, How the Criminalization of Drug Use Fuels the Global Pandemic"

IDHDP joins the distinguished Global Commission on Drug Policy in condemning the drug war as a failure and a major factor sustaining the global HIV/AIDS epidemic. We support their call for immediate, major reforms of the global drug prohibition regime to correct the policy distortions that favor criminal justice over public health evidence-based addiction treatments.

The Global Commission on HIV and the Law: A Movement for HIV Law Reform

This session addresses the political dimensions of the Commission's recommendations as an essential ingredient for successfully using the law to scale-up effective HIV responses.

Correlation between illicit substances, unsafe sexual behavior and symptoms suggesting sexually transmitted infections among male clients of female sex workers in Bangladesh

Comprehensive HIV Prevention for People Who Use Drugs: Ways Forward for Inclusion of Needle and Syringe Exchange Programmes

This session addresses the potential impacts of restrictions on NSEPs, and propose ways forward for public health actors, community stakeholders, and drug users themselves to maintain and expand comprehensive services, including needle and syringe exchanges, despite the limitations in funding, restrictive political environments, and other barriers to the implementation of this preventive intervention.

New publications

Methadone replacement therapy: tried, tested, effective?

Two Scottish doctors debate, the efficacy of methadone maintenance (under attack in the Scottish media). IDHDP member, Dr Roy Robertson, makes the case that methadone has been well tested, is cheap and acceptable to the patient and results in visible improvement. Dr Daniels argues that methadone treatment is philosophically ill-conceived, ethically dubious, and costly. He also highlights evidence that the treatment is potentially harmful to both patients and those in contact with them.

West Africa 21012 ATS Situation Report

A report on the growing evidence that West Africa is a manufacturing hub for amphetamine-type stimulants (ATS) and trafficking of drugs.

HIV prevention, treatment and care in prisons and other closed settings: a comprehensive package of interventions

UNODC's new policy brief highlights two guiding principles, namely that "prison health is good public health" and that a human rights-based approach and the principle of equivalence of health in prisons are key. The report proposes a comprehensive package of 15 interventions to address HIV in prisons settings.

Guidelines for the evaluation of drug prevention: a manual for programme planners and evaluators (second edition)

This edition is an updated version of the original EMCDDA guidelines, which contains new methods, concepts and examples of currently available drug prevention interventions and which provides a framework for carrying out an evaluation. The content has also been updated with developments in online EMCDDA drug prevention and evaluation resources.

Torture in the Name of Treatment

Asia Drug Detention - Human Rights Watch Report: summarizes HRW's findings over five years of research on compulsory drug "treatment" centers in China, Cambodia, Vietnam, and Lao PDR.

Global Commission on HIV and the Law: Risks, Rights & Health

Global Commission on HIV and the Law presents a coherent and compelling evidence based report on human rights and legal issues relating to HIV and how evidence and human rights based laws can end an epidemic of bad laws and transform the global AIDS response.

WHO: Guidance on Prevention of Viral Hepatitis B and C Among People Who Inject Drugs

The guidance is the first step in the provision of comprehensive guidance on viral hepatitis surveillance, prevention and

treatment by the World Health Organization.

Drugs Policy is AIDS Policy

The Canadian Drug Policy Coalition (CDPC) details their vision and insights on the drug situation in Canada, including articles by Professor David Nutt, author of "Drugs- Without the Hot Air"; Dan Gardner, author of "Future Babble"; Dan Werb, Co-Founder, International Centre for Science in Drug Policy, and more.

The Robert Carr Doctrine

This document highlights the principles for a meaningful response to HIV among the world's key affected populations.

Home Affairs Committee: Drugs

Danny Kushlink, Transform Drug Policy Foundation, Niamh Eastwood, Release, Tom Lloyd, former Chief Constable of Cambridgeshire Trevor Pearce, Director General, Serious and Organised Crime Agency give evidence to the Home Affairs Committee in relation to the inquiry into drugs.

A Balancing Act: Policymaking on Illicit Drugs in the Czech Republic

The third study on good practices in national drug policy from Global Drug Policy Program, the report shows how the Czech Republic has kept low-threshold health services high on the drug policy agenda, engaged with civil society, invested seriously in research on the impact of drug policy, and managed the shifting political winds of public attitudes toward drugs.

The Global State of Harm Reduction 2012; Towards an Intergrated Response report

This report highlights the major developments in harm reduction policy adoption and programme implementation that have occurred since 2010, enabling some assessment of global progress. It also explores several key issues for developing an integrated harm reduction response, such as building effective harm reduction services for women who inject drugs, access to harm reduction services by young people, drug use among men who have sex with men, and global progress toward drug decriminalisation and sustainability of services in challenging environments.

Drugs Meter

Check out the new Drugs Meter, a new tool which allows people to get non-judgmental feedback on their drug use, including alcohol.

A Quiet Revolution: drug decriminalisation policies in practice across the globe

Release's new report examines the policies of over 20 countries that have adopted some form of decriminalisation of drug possession. The main aim of the report is to look at the existing research to establish whether the adoption of a decriminalised policy led to significant increases in drug use - the simple answer is that it did not.

Why doctors should read this report:

Chris thinks about decriminalisation in response to Release's report. We know criminalisation of individuals can impact them for the rest of their lives, affecting employment and education, not to mention their health and welfare. It stigmatises people and can push them further into the margins of society. As doctors, many of us may not have thought much about decriminalisation and its potential to improve the health and overall well-being of people who use drugs, but even for those of us who have, read this report: it is an eye opener. I recommend that you read this report and then as a group lets discuss whether IDHDP should firstly make a statement and secondly, talk about whether we agree with Release's call that decriminalisation is the first step in reform of our drug laws.
